SUPPORT GROUPS: DOOR OF HOPE PROVIDES SUPPORT GROUPS FOR PEOPLE WHO HAVE EXPERIENCED ABUSE AND TRAUMA. DURING 2019 OUR SUPPORT GROUP TEAM INCREASED TO 28 LEADERS AND LEADERS IN TRAINING. WE GREW FROM 20 GROUPS IN 2018 TO 41 SUPPORT GROUPS IN 2019 FOR WOMEN, MEN, TEENS, AND CHILDREN. THESE GROUPS HAD A TOTAL OF 235 ADULT PARTICIPANTS AND 34 PARTICIPANTS IN THE GROUPS FOR TEENS AND CHILDREN.

TRAUMA RECOVERY & PRAYER MINISTRY: IN 2019 WE PROVIDED OVER 229 TRAUMA RECOVERY PRAYER MINISTRY APPOINTMENTS. WE HAVE 31 MEN AND WOMEN WHO HAVE BEEN TRAINED TO SERVE ON OUR MINISTRY TEAM. BOTH MEN AND WOMEN, FOUND A SAFE PLACE TO PROCESS THE TRAUMA THEY HAVE SUFFERED. WE HEAR TESTIMONIES OF GOD'S HOPE AND LIFE CHANGING LOVE EVERY WEEK. WE ARE CONTINUING TO PROVIDE TRAINING FOR NEW PEOPLE TO JOIN OUR TRAUMA RECOVER PRAYER MINISTRY TEAM AS THIS NEED CONTINUES TO GROW.

WE HAVE HAD TWO FAMILIES PROVIDE SAFE HOUSING FOR OUR WOMEN.
