SUPPORT GROUPS: DOOR OF HOPE PROVIDES SUPPORT GROUPS FOR PEOPLE WHO HAVE EXPERIENCED ABUSE AND TRAUMA AT ANY TIME IN THEIR LIVES. DURING 2020, OUR SUPPORT GROUP LEADERSHIP TEAM INCREASED TO 38 LEADERS AND LEADERS IN TRAINING. WE HOSTED 55 SUPPORT GROUPS FOR MEN AND WOMEN, WHICH IS A 34% INCREASE FROM 2019 (41 GROUPS. WE HAD 331 ADULT PARTICIPANTS IN 2020 WHICH WAS AN INCREASE OF 23% FROM 2019. WE HAD SIX DIFFERENT CURRICULUM OPTOINS FOR WOMEN, TWO FOR MEN, AND ONE NEW CURRICULUM OPTION THAT COUPLES DID TOGETHER.

TRAUMA RECOVERY & PRAYER MINISTRY: IN 2020 WE PROVIDED OVER 465 TRAUMA RECOVERY PRAYER MINISTRY APPOINTMENTS. THIS WAS AN INCREASE OF 103% FROM THE 229 WE HAD IN 2019. WE HAVE 33 MEN AND WOMEN WHO HAVE BEEN TRAINED AND WHO SERVED ON OUR MINISTRY TEAM IN 2020. BOTH MEN AND WOMEN FOUND A SAFE PLACE TO PROCESS THE TRAUMA THEY HAVE SUFFERED. WE HEAR TESTIMONIES OF GOD'S HOPE AND LIFE-CHANGING LOVE EVERY WEEK. WE ARE CONTINUING TO PROVIDE TRAINING FOR NEW PEOPLE TO JOIN OUR TRAUMA RECOVER PRAYER MINISTRY TEAM AS THIS NEED CONTINUES TO GROW.

CONFERENCES AND WORKSHOPS: WE HOSTED ONE WORKSHOP IN FEBRUARY OF 2020 WITH 22 PARTICIPANTS BEFORE THE COVID19 RESTRICTIONS CAUSED US TO PUT A HOLD ON ALL CONFERENCES AND WORKSHOPS. WE ALSO PARTNERED WITH TWO EQUINE THERAPY TRAINING CONFERENCES THAT INCLUDED 20 PEOPLE IN EACH ONE FOR A TOTAL OF 40 PARTICIPANTS. OUR BEAUTY INSTEAD OF ASHES CONFERENCES ARE FOR WOMEN WHO HAVE EXPERIENCED ANY KIND OF ABUSE AND FOR WOMEN WHO WANT TO LEARN HOW TO HELP OTHER WOMEN WHO ARE CAUGHT UP IN THE ABUSE CYCLE. WE PLAN TO RESUME HOSTING THESE CONFERENCES AGAIN IN 2021. WE ARE ALSO PLANNING TO HOST WORKSHOPS TO HELP PROVIDE EDUCATION FOR THE COMMUNITIES BOTH IN PERSON AND THROUGH WEBINARS.
