SUPPORT GROUPS: DOOR OF HOPE PROVIDES SUPPORT GROUPS FOR PEOPLE WHO HAVE EXPERIENCED ABUSE AND TRAUMA AT ANY TIME IN THEIR LIVES. DURING 2021, OUR SUPPORT GROUP LEADERSHIP TEAM INCREASED TO 35 LEADERS AND LEADERS IN TRAINING. WE HOSTED 53 SUPPORT GROUPS FOR MEN AND WOMEN, SUPPORT GROUPS PROVIDE A SAFE PLACE FOR PEOPLE TO HEAL AND RECEIVE SUPPORT

Trauma Recovery & Prayer Ministry: In 2022 we provided over 218 Trauma Recovery Prayer Ministry appointments. We have 34 men and women who have been trained and who served on our ministry team in 2022. Both men and women found a safe place to process the trauma they have suffered. We hear testimonies of God's hope and life-changing love every week. We are continuing to provide training for new people to join our Trauma Recover Prayer Ministry team as this need continues to grow.

CONFERENCES AND WORKSHOPS: We hosted three workshops in 2022 for a total of 72 participants. Two workshops were on Building Joy in Ourselves and Others and the 3rd was called Hope Builders Workshop. These workshops serve our communities with practical information on how to heal and grow in their own journey, but also with tools to help other people. We also partnered with two Equine Assisted Therapy Training Conferences in Mankato in 2022 with a total of 36 participants.
